

# Terms and Conditions of Use (updated Oct 2020)

## Introduction

These terms and conditions apply between you, the User of this Website (including any sub-domains, unless expressly excluded by their own terms and conditions), and Mynydd Marketing Ltd, the owner and operator of this Website.
